Update on the Conclusions on Climate Disclosures Requirements by the HKEx and Practical Implementation Guidance to the listed issuers

Overview:

The Stock Exchange of Hong Kong Limited (the Exchange), published conclusions to its consultation on the enhancement of climate-related disclosures under its environmental, social and governance (ESG) framework (New Climate Requirements) on 19 April 2024.

The key features of the New Climate Requirements are as follows:

- 1. The New Climate Requirements are developed based on IFRS S2. Implementation reliefs including proportionality and scaling-in measures are introduced to address concerns over the reporting challenges that some issuers may face.
- 2. The amended Listing Rules will come into effect on 1 January 2025. A phased approach is adopted for the implementation of the New Climate Requirements.

This course provides a comprehensive update to the ESG landscape in Hong Kong, one of the leading financial centers in Asia. Participants will gain a deep understanding of the regulatory requirements and recommendations, green finance, carbon market, and observation report in Hong Kong.
