Course Outline:**Hong Kong Regulatory Landscape 2026: What Keeps Regulators Up at Night?**

- Overview of current priorities of SFC, HKEX and HKMA as they relate to listed issuers: corporate governance, disclosure quality, virtual assets, AML/CTF and climate risk.
- Recent enforcement themes: non disclosure of material information (e.g. notifiable and connected transactions), deficiencies in internal controls and risk management, and remedial expectations.

Update on HK's Virtual Assets and Stablecoins regime

- Hong Kong's virtual asset regulatory architecture: SFO/AMLO dual licensing regime for virtual asset trading platforms, fit and proper requirements, token admission standards and AML/CTF expectations.
- Stablecoin regime: new Stablecoins Ordinance (Cap. 656) effective August 2025, scope (fiat referenced stablecoins), licensing of stablecoin activities and restrictions on who can "offer" specified stablecoins to the Hong Kong public.
