Hong Kong Stock Exchange (HKEX) released the consultation conclusions in December 2019 regarding the enhancement of its ESG reporting requirements for listed companies. Companies will be required, starting from fiscal year commencing on or after 1 July 2020, to make additional disclosures regarding their ESG governance, environmental targets and social performance. Also, enterprise risks in relation to supply chain and climate change will need to be assessed and reported. This seminar will provide an overview of the new HKEX's ESG requirements, and advise companies on how to prepare for the compliance, supported with practical examples.
