In recent years, the Securities and Futures Commission ("SFC") and the Hong Kong Stock Exchange ("HKEx") have stated on different occasions that they will strengthen the supervision, enforcement and censures of listed companies for breach of listing rules, and have disclosed hundreds of non-compliance cases of listed companies in the past years.

The speaker will give a quick summary of the HKEx breach cases disclosed in the first half of 2021 and highlight the related internal control deficiencies that worth management to pay attention to.

Moreover, given the ongoing improvement trend of corporate governance, HKEx has issued a Consultation Paper on Review of Corporate Governance Code and Related Listing Rules in April 2021. The speaker will give a brief summary of the proposed amendments to the Corporate Governance Code.

From 1994 - 2001, he was appointed the role of executive director/ CFO of three listed companies in Hong Kong responsible for IPO, financial management and compliance function. From 2001 to 2007, he was the Managing Director of a licensed corporate finance firm and also a registered and Responsible Officer of Corporate Finance (type 6) under the Securities and Futures Ordinance and has been involving in a number of major corporate transactions, takeovers, and restructurings, and private equity placements. Since 2005, he started his own professional practices and engages extensively in transacting advisory, corporate governance practices and corporate training.

Mr. Kwok has been acting as an Independent Non-Executive Director/ Chairman of audit committee of a number of Hong Kong listed companies, familiar with Listing Rules and Corporate Governance Code & Practices.
